



## **GPCAAC ART WALK ARTIST RULES & APPLICATION**

GPCAAC's annual ArtWalks are held on the 4th Thursday of the months of May through September from 5-8 pm. Setup begins at 4 pm. Artists may participate in the walks for free, providing that they have filled out an application and signed up with GPCAAC in advance. Artists are granted a 10' x 10' space on local walkways throughout downtown Port Clinton. Check with the GPCAAC tent the day of the event to locate your space.

1. We recommend you print and keep the papers for your records.
2. Carefully review and sign the Liability Waiver.
3. Fill out the artist profile attached.
4. Submit samples of your work. You may do this by submitting a link to your online portfolio or by emailing one photo that shows a representative sample of each type of product you intend to display.

**The deadline to apply for an Art Walk is the first Friday of the month.** For example, if you would like to attend the May Art Walk, you must apply no later than the first Friday in May.

**Applications are reviewed twice per month and approved for the calendar year.**
